ORDINANCE TO AMEND THE CODE OF THE BOROUGH OF METUCHEN, CHAPTER 185, ENTITLED "VEHICLES AND TRAFFIC", SPECIFICALLY, SECTION 185-27 - LOADING ZONES TO ADD A LOADING ZONE ON CENTER STREET

NOW THEREFORE BE IT ORDAINED by the Mayor and Council of the Borough of Metuchen that § 185-27, entitled, "Loading zones" of the Code of the Borough of Metuchen is hereby amended to state as follows:

§ 185-27 Loading zones.

The locations described are hereby designated as loading zones. No person shall park a vehicle in said location during the times indicated other than for the loading or unloading of goods and materials.

BE IT FURTHER ORDAINED that this ordinance shall be in full force and take effect after final passage and publication, as required by law.

BE IT FURTHER ORDAINED by the Mayor and Borough Council of the Borough of Metuchen that all Borough officials shall take all necessary actions to in order to effectuate the within Ordinance, including but not limited to the installation of sign/s in the above designated area.
