BOROUGH OF METUCHEN COUNCIL MINUTES REORGANIZATION MEETING January 1, 2022 3:00 PM

The Reorganization Meeting of the Borough Council was held at Metuchen High School on January 1, 2022.

The Meeting was called to order at 3:10 p.m. by Mayor Busch.

Adequate Notice of this meeting has been given in accordance with the Open Public Meeting Act, pursuant to Public Law 1975, Chapter 231. Said notice was sent to the Home News Tribune and Star Ledger on December 21, 2021, posted in Borough Hall, and on file in the Clerk's Office. All requirements of the "Open Public Meetings Act" have been satisfied.

Invocation

The Invocation was given by Rev. Dr. Ronald L. Owens of the New Hope Baptist Church.

Mayor Busch asked all to rise for the flag salute.

Swearing-In of Councilmembers

Councilmember-Elect Jason Delia was sworn in by Assemblyman Sterley Stanley.

Councilmember-Elect Joel Branch was sworn in by Congressman Frank Pallone, Jr.

Roll Call

Mayor Busch asked for a roll call.

Present were Councilmembers Branch, Delia, Hirsch, Kandel, Rasmussen, Council President Koskoski, and Mayor Busch. Also present were Denis Murphy, Borough Attorney, Melissa Perilstein, Borough Administrator, and Deborah Zupan, Acting Borough Clerk.

Election of Council President

Council President Koskoski made a motion to nominate Councilmember Delia for Council President, second by Councilmember Kandel.

Mayor Busch asked if there were any other nominations. With no further nominations, Mayor Busch closed the nominations. Mayor Busch asked for a voice vote, with all in favor, Councilmember Delia was elected Council President for 2022, 6-0.

Mayor's Annual Address

Good afternoon everyone and welcome. I begin by congratulating Joel Branch, our newest Councilman! I am lucky to have had the opportunity to work with Joel during the last year when he served on our Borough Planning Board. During the course of his service, I was struck by his keen insight and leadership on many important issues facing our Borough. I look forward to working with him in his new capacity. And speaking of new roles, we congratulate Jason Delia on his relection and swearing-in and we are incredibly lucky that he has decided to serve as our Council President. He is one of the hardest working people here, he has boundless enthusiasm for our community, he is dedicated to making our Borough better, safer, and stronger and his enthusiasm is contagious. I am certain that the Council Members join me in expressing that we so look forward to working with you

in your new capacity as our Council President.

The role of Council President is extraordinarily important in our Borough form of government and Jason is taking the reins from a titan. Linda Koskoski became our Council President two weeks after I became Mayor. She has served in that role for four years during which her leadership style has been exceptionally effective at helping us deal with and resolve the many complex challenges our Borough has faced. Linda is passionate and

direct – kind and empathetic – and she is deeply mindful of the way that our decisions impact our entire community. We have relied on her dedicated and extraordinary leadership as our Council President to ensure that we have considered all of the facets of every issue and the decisions we have made during her tenure reflect Linda's careful consideration, commitment and thoughtfulness. We absolutely could never have done all of what we have without you, Linda.

Every year at this very organization meeting, the Mayor of our Borough is called upon to give remarks. While each Mayor has used this opportunity with varying purposes, I have approached writing my remarks as a means of marking time and while some of you have quite fairly criticized me for taking longer than you would like, I respectfully request that you allow me the opportunity to explain myself. This speech is important - not because I

say so - but it is important because writing and delivering it allows me to reflect on the year that just ended and to set priorities for our new year ahead. While preparing these remarks, I consider the state of the Borough and they provide us with the opportunity to hold us accountable to our community and to ourselves. What worked? How can we improve? What

choices will we make? What is the status of our current projects? What new projects should we consider in the year ahead? The world, our society and our economy are rapidly changing: how should Metuchen respond and plan for its future? Our job as municipal officials is to identify the local challenges that we face and lead our community forward with solutions. I am increasingly struck by how many focus intensely on the Washington

gridlock yet largely ignore the important decisions we make right here in Metuchen – decisions which in most ways have a much greater impact on all our daily lives.

It is no secret that many local governments across the State and America have had difficulty navigating through the pandemic. Some have struggled with maintaining municipal services, others have had to abandon long planned projects due to lack of revenue, and many are faced with a large number of commercial and residential vacancies. Here in Metuchen,

however, we have met challenges head on and in some instances, quite remarkably. Actually, our Borough is even stronger than it was before the pandemic began.

During the last few years, we have acted deliberatively in response to the changes around us to put Metuchen in the most advantageous position possible in the face of every known challenge. In the process, others have taken notice of the impact that a responsive local government like ours can have on the desirability of a community.

Take the Borough's bond rating, for example. In the Fall, Moody's Investor Service upgraded our Borough's bond rating to Aa1, the second highest possible rating for a local municipality. Moody's explained that the new rating "reflects the borough's positive financial trend which has led to a very strong reserve position" and "[w]hile there were some modestly negative effects from the pandemic, the borough's finances were not materially

impacted." A high bond rating like this reflects extraordinary third-party confidence in the financial decisions that we have made.

And look no further than our thriving downtown to see how we were able to protect Metuchen's biggest asset throughout the pandemic. When all current planned business openings are complete in 2022, there will just be one vacant storefront on Main Street despite the extraordinary challenges that came with the pandemic and a variety of other economic factors that tend to disadvantage the kinds of small businesses that reside here. This remarkable statistic of only one vacant storefront seemed almost unimaginable in 2016, the first year of the Metuchen Downtown Alliance. Yet here we are, just six years later, surpassing the expectations of even the most optimistic among us.

It doesn't take a trained financial analyst to advise that the strength of a municipal housing market is another important indicator of a community's positive economic position. According to local realtors, Metuchen's housing market is among the strongest it has ever been. Perhaps most significantly is the fact that we have become a regular part of the "where to live" conversation among families looking to move to the region. This past summer, my family and I enjoyed hosting nearly 200 new residents and their families at our home. Many of them had moved here just before or during the pandemic and had not yet had the opportunity to meet their neighbors. In speaking with them, it was heart-warming to hear the reasons that they chose Metuchen and how consistent those reasons were: the desirability of our region, the quaintness of our downtown, the diversity of our residents, and most importantly, our tight knit community.

This extraordinary sense of community is, without question, attributable to the high level of municipal engagement among our residents and vice versa - the high level of engagement among our residents can be attributable to our extraordinary sense of community because with one, comes the other. During this time when cynicism of government is at an all-time high and apathy has taken hold throughout the nation, Metuchen is alive with volunteerism, commitment, and pride because such a significant majority of us understand that when we get involved in our community, we help chart its course. With more engagement, we become even more responsive to one another and we are better able to advocate for the kinds of things that reflect the

needs and the desires of our community in ways that will help us improve our lives in the most authentic ways possible. Here are just a few examples.

As some of you may recall, during last year's reorganization meeting, vaccines had only been available for two weeks. The availability of the vaccine offered hope and then, desperation when it quickly became apparent that vaccine appointments were conspicuously challenging to find, even for the most resourceful people. In the face of this difficulty and uncertainty, our community all worked together to help one another become vaccinated as quickly as possible by using a method that was so effective, that it was soon replicated by other communities throughout the State. The Borough helped establish "Team Vaccine", a group of 24 dedicated and resourceful residents who helped over one thousand Metuchenites secure difficult-tofind appointments during those early days. In some cases, Team Vaccine members even shuttled residents in need of rides to their appointments. How wonderful and considerate that was and truly an example of our #OneMetuchen mantra.

We also worked with our School District Officials to help it forge a close relationship with Hackensack Meridian to vaccinate as many school staff members as possible. Exceptional efforts like these rapidly made Metuchen one of the most vaccinated municipalities in the State. The combination of these efforts kept our infection rate lower than it would have otherwise been and allowed more of our children to get back to school.

As a Borough, we understand the value in forging good working relationships with our County and State agencies and officials. We know that partnering with other levels of government can assist in overcoming financial obstacles and help us address issues of great concern to our community. We understand that as a municipality we can't achieve all we

need alone, and that meaningful leadership involves advocacy by members of local government on behalf of our Borough. By working with officials from the Governor's office, our federal representatives, our State Legislators, and of course, our County Commissioners, we secured over a million dollars in grants and financial support for our Borough last year. These contributions will help support critical projects like, for example, the paving of multiple streets, a new bridge at Kahn's Crossing, renovations to our

Senior Center, and the removal of dangerous trees throughout the Borough. Among the most significant grants the Borough received last year is one that resulted from the hard work of our State Legislators in conjunction with the Governor's office which will result in a complete renovation and re-turfing of Myrtle Field, the most frequented park in our Borough. The work on Myrtle Field is scheduled to be completed in time for the Spring sports season.

When Tropical Storm Ida impacted many of our residents, we worked closely with County, State, and federal officials to ensure that our residents had the support they needed from FEMA to address the storm's overwhelming financial burdens. Additionally, the Borough waived all permit fees for residents who were forced to have work performed to their homes because of the storm.

We teamed up with our State Legislators and Edison Township when an Edison developer attempted to mislead the Department of Environmental Protection (DEP) in an attempt to develop the Lucille Ball Pond in the Clive Hills neighborhood. This pond is actually a glacial kettle pond that has existed since the ice age, and so we invited DEP representatives to the pond to show them our concerns, first-hand. Just days later, we were advised that our collective advocacy resulted in a determination that has now saved this environmental treasure.

We learned that the pandemic had resulted in residents being unable to make important motor vehicle appointments. After repeatedly expressing concerns over this issue, we were able to secure the mobile MVC unit to be stationed in the Borough twice, resulting in hundreds of appointments made for residents, conveniently right here in Metuchen without them having to wait at one of the congested motor vehicle sites.

When we were notified that our water source contained elevated levels of PFOA, we immediately responded by forming a cooperative group with the Mayors of other regional municipalities and ultimately filed a lawsuit against Middlesex Water. Just weeks later, Middlesex Water announced its intention to replace our water supply with a safer source.

After one of our neighbors, Oscar Zanoni, was struck and sadly killed by a vehicle on Route 27 in Edison, we worked closely with our legislators to craft and advocate for the passage of a safe passing law, now known as "Oscar's Law." Council President Delia's efforts were particularly crucial to its passage and it was signed by the Governor on August 5th. [Oscar's partner Wendy Kukoski is with us today.]

We continue to hear our residents' significant concerns about the raising of historic structures. We have now hired a professional expert to develop a historic preservation element, which is a significant step to help protect historic resources in our community like structures, parks, archeological sites, and districts.

During some of last winter's heavy snows, residents understandably raised concerns that some private contractors and residents were dumping snow back into our streets making it more difficult to clear our roads. In response, we adopted an ordinance which strengthened our ability to prohibit such dumping of snow onto plowed streets and curb ramps. That ordinance will help resolve that issue for the upcoming winter.

When a number of residents brought the disrepair of many of the Borough's historic blue street markers to our attention, we took steps to initiate and finalize the street marker beautification project. We expect that every street marker in the Borough will be repaired by the end of the next few months.

In the year ahead, we will continue to work toward finalizing many of our outstanding projects. For example, we are so very excited to take our first step in fulfilling Green Print, our community-wide vision for recreation which we launched last Spring. Just a week and a half ago, Middlesex County announced its intention to work with our Borough to acquire and manage the Dismal Brook Preserve section of the Peter J. Barnes III Wildlife Preserve, previously known as the Dismal Swamp. This project, which many people know as the Gulton Property, will transform the northwest

quadrant of our Borough by opening to the public, Metuchen's most beautiful, natural asset and the largest section of open space for passive recreation. Plans for the Preserve include an extensive trail system for walking, hiking, biking, and strolling. There will be boardwalks that traverse above wetlands, a footbridge for walking over the brook, interpretive signage to give visitors some context for both the preservation of the surrounding plants and wildlife and the extensive history of the property, and possibly an observation tower for bird watching.

Many residents do not even know that this natural wonder exists because it has been largely blocked from use by dilapidated warehouses and previously contaminated by the former Gulton factory which once stood there. However, the present owner of the property has spent approximately ten million dollars to perform the work necessary to make this space usable by removing all of the illegally dumped debris and replacing the contaminated soil with fresh soil. In fact, during the last few weeks, 3,000 native species trees were planted on the Dismal Brook property by the owner. At some point, our residents and visitors will be able to exit the expanded Greenway to enjoy the Preserve or use the convenient public parking area or bike racks to access this natural resource. This is a truly transformational project

for our Borough which will protect and improve this blighted land for our future enjoyment.

Also, we continue to perform critical work in the planning phase for the Metuchen Arts District. We have always known that the acquisition of the Forum Theatre was just one step in an overall vision for a successful District. While we would all like for it to be open immediately, we must ensure that whatever we do is both successful and have a minimal impact on our taxpayers. This is why we continue to work closely with our theatre and development consultants to perfect a responsible business model that charts a clear, fiscally responsible avenue for success.

Additionally, we continue to work to finalize details for the construction of a new Emergency Services Center that will house our Fire Department and EMS. During the last few years, several real estate and cost obstacles have arisen that have delayed this project for far longer than any of could have imagined. As we continue to identify the proposed structure's most important features by working closely with representatives of our Fire

Department and EMS, we are optimistic that our Borough will make some important, final decisions within the next few months.

Metuchen's future is bright. We have laid the critical and foundational groundwork for several essential projects in our community that will serve and resonate for generations. These projects are designed to invest in our infrastructure, support our essential workers, continue to stabilize our local economy, and enhance our public spaces. As we move Metuchen forward, it will remain a desirable place for people to live, businesses to succeed and families to grow.

In spite of many obstacles and during the course of unprecedented times, Metuchen has come further than most of us could have imagined and we are now stronger than ever. As elected officials, during an increasingly polarized time in our country, we understand that some may view government and its officials cynically, especially during times of disagreement. But, we are proud to lead with integrity and with a commitment to listening to your voices. When we agree and when we don't, we will always be a Borough that prides itself on

healthy discourse and careful deliberation. The Borough's success is inextricably tied to our collective success. Together we have created a place where goodwill, honesty, kindness, equity, tolerance, inclusion, and conviction make up the cornerstone of our community. People choose Metuchen for its heart and people are bound together because of its soul. For all of these reasons, it is a privilege and honor to continue to represent all of you as we invest in the future of our Borough together.

Public Comment

RESOLUTION 2022-01

RESOLUTION ADOPTING RULES AND REGULATIONS OF THE METUCHEN BOROUGH COUNCIL FOR 2022

BE IT RESOLVED, by the Mayor and Council of the Borough of Metuchen, that the following Rules and Regulations be and the same are hereby adopted as the rules and regulations of the Council for the year **2022** to continue in full force and effect until altered, amended, or made void by appropriate action of the Council.

RULE ONE

Regular meetings of the Council shall be held in the Borough Hall on Mondays of each month, or as otherwise noted, at the hour of seven thirty (7:30) p.m. provided, however, that in the event any such meeting shall fall due upon a legal holiday, then such regular meeting shall be held on the Tuesday following such legal holiday to be held at Borough Hall.

Special meetings shall be called and held as provided for by statute, and upon written notice, designating the time and place of meeting, signed by the Mayor or by four members of the Council, which notice shall be given to all members of the Council personally or left at their place of residence at least forty-eight (48) hours before the time of the meeting. Emergency meetings as provided in Open Public Meetings Act may be called on such notice as required by law.

Adjourned meetings shall be called to order and held at the time and place appointed by the motion or resolution under which it is held.

Agenda meetings of the Council shall be held at Borough Hall at the beginning of each regularly scheduled meeting of the Council. If agenda meetings fall upon a legal holiday, then such agenda meeting shall be held on the Tuesday following such legal holiday to be held at Borough Hall. The meeting shall begin at 7:30 p.m.

RULE TWO

The Mayor shall preside at all meetings; in their absence the President of the Council shall preside; and in their absence, the senior member of the Council shall preside.

RULE THREE

The order of business at regular meetings shall be as follows:

- 1. Announcement of compliance with the Open Public Meetings Act, Invocation, Pledge of Allegiance and Roll Call
- 2. Agenda Session
- 3. Comments from the Public
- 4 Proclamations or Resolutions Honoring
- 5. Approval of Minutes
- 6. Public Hearings and Action on Ordinances
- 7. Introductions and Action on Ordinances
- 8. Communications Consent Agenda
- 9. Other Communications
- 10. Report of Officers
- 11. Report of the Borough Administrator
- 12. Report of Borough Council Members
- 13. Report of the Mayor
- 14. New Business Consent Agenda
- 15. Other New Business
- 16. Adjournment

RULE FOUR

The order of business for agenda meetings shall be generally as follows:

- 1. Announcement of compliance with the Open Public Meetings Act and Roll Call
- 2. Items for the regular agenda meeting
- 3. Reports of Council members
- 4. Report of Mayor
- 5. Reports of other Borough Officials
- 6. Meetings with any other persons or bodies

- 7. Any other business including items from which public may be excluded under Open Public Meetings Act
- 8. Adjournment

RULE FIVE

Every ordinance and resolution submitted for the consideration of Council shall be in writing. Every ordinance so submitted, including amendments to existing ordinances, shall be accompanied by a brief interpretive statement explaining the purpose of the ordinance or amendments. Any amendments to existing ordinances shall be provided in "redline" format when necessary showing the original text, along with proposed changes. No ordinance, or amendment to existing ordinance, shall be introduced unless a copy thereof is made available to each Councilmember no later than three days prior to the meeting at which the ordinance shall be introduced. The Council shall not be asked to consent to the appointment of officers of the Borough or members of Advisory Boards, Commissions and Committees, unless the name of the nominee for appointment is made known to each Councilmember no later than three days prior to the meeting at which consent shall be asked. The Council President shall be notified of all items on the agenda.

RULE SIX

A. In General

Since no substantive action will ordinarily be taken at agenda meetings, the only votes contemplated at such meetings are those to determine whether a matter will be placed on the agenda for the regular meeting, any points of order, and motions in respect to adjournment. Such votes shall be by a majority of members present, with the presiding officer voting only in case of a tie. However, nothing herein shall preclude the Council to adopt resolutions at agenda meetings to act on matters from which the public may be excluded pursuant to Sections 7 and 8 of the Open Public Meetings Act, or to vote on holding emergency meetings pursuant to the requirements of said Act. Procedure at agenda meetings not specifically set forth herein shall be governed by the rules hereinafter applicable to regular meetings.

B. Consent Agenda

The Council may establish a Consent Agenda for any regular or special meeting. The consent agenda shall apply to communications, resolutions and motions but shall not apply to ordinances. The Consent Agenda may then be approved by motion, by majority vote, without the necessity of the Borough Clerk reading the title or the actual body of the communications, resolutions, and motions on the consent agenda. If at any time prior to the adoption of the consent agenda at the regular meeting or special meeting, any Councilmember objects to placing or the existence of an item on the consent agenda, the matter shall be promptly deleted from the consent agenda and shall be voted on separately.

RULE SEVEN

A quorum for all meetings shall consist of four Councilmembers, or the Mayor and three Councilmembers.

RULE EIGHT

The order of business of agenda meetings may be modified by a vote of the majority of Councilmembers present.

RULE NINE

The Borough Clerk is directed to take the minutes of all meetings, which shall be distributed to all Council members.

RULE TEN

When a question is under debate, no motion shall be in order unless for recess, to lay on the table, to call the previous question, to postpone, to refer, or to amend, and these shall be precedence in the order in which they are named, the first three of which shall be decided without debate. A motion to refer, until it is decided, shall preclude all amendments for the main question.

RULE ELEVEN

The ayes and nays may be called by a member, and being called, the names of those who voted for or against the question, or abstained, if requested by any member, shall be entered in the minutes.

RULE TWELVE

When a member intends to speak upon a question, they shall acknowledge the chair only in their opening remarks; thenceforth they shall confine themself to the question and avoid personalities. Should more than one member rise to speak at the same time, the presiding officer shall determine who is entitled to the floor.

RULE THIRTEEN

The previous question may be called for by any member, and if seconded, shall be put in this form, "Shall the main question be put?", and until it is decided, shall preclude all amendments to the main question and all further debate.

RULE FOURTEEN

Any member may call another to order while speaking when the debate shall be suspended, and the member shall not speak until the point of order is determined. When the appeal from the

decision of the chair is called for, no other question but the point of appeal shall be debated, when the question shall be put, "Shall the decision of the chair be sustained?"

RULE FIFTEEN

When any question is stated, and by Council agreed to be put, no member shall be at liberty to withhold their vote without the consent of the Council.

RULE SIXTEEN

A motion to adjourn shall always be in order and decided without debate.

RULE SEVENTEEN

The proceedings of the Council where not specifically mentioned herein, shall be governed by <u>Robert's Rules of Order</u>.

RULE EIGHTEEN

Except as otherwise provided by law, all action of the Council, including the passage of ordinances, resolutions, creations of committees and the appointments or consent to the appointments of any officers of the Borough or members of advisory boards, commissions or committees, shall be by a majority vote of those members of the Council present.

RULE NINETEEN

Except as otherwise provided by law or specific rule, the Mayor shall appoint the Chair of all committees. It shall be the Chair's duty to give notice of the time and place of meetings for the purpose of preparing the business for which they are appointed.

RULE TWENTY

The names of members of the Council, when called by the Clerk on any questions, shall be called alphabetically, with the Presiding Officer's name called last. Reports of Councilmembers shall be given in reverse alphabetically by order except that the Council President shall be first.

RULE TWENTY-ONE

All bills shall be itemized and certified to by the claimant as being correct, just, and true. Before any bills shall be presented to the Council for payment, it shall have first been certified by the officer incurring the indebtedness. Before payment all vouchers must be approved and signed by the Administrator.

RULE TWENTY-TWO

No rule of this Council or part thereof shall be amended, suspended, or superseded without at least the consent of two-thirds of the entire Council, except as provided in Rule Seven.

RULE TWENTY-THREE

All rules of the Borough Council heretofore adopted and inconsistent herewith are and the same are hereby repealed.

RULE TWENTY-FOUR

The Presiding Officer at the commencement of every meeting shall announce publicly and shall cause to be entered in the minutes of the meeting an accurate statement that adequate notice had been given to the public of the time, place of the meeting, and the manner in which said notice was given, Section 5 of the Open Public Meetings Act.

RULE TWENTY-FIVE

The Borough Clerk shall be the Borough official responsible for posting, mailing, and filing of the "Adequate Notice" of meetings as provided in the Open Public Meetings Act including an annual schedule of meetings and any revisions thereof as set forth in Section 13 of said act.

RULE TWENTY-SIX

The Borough Clerk shall be the Borough official responsible for making minutes of Council meetings available to the public pursuant to Section 9 of the Open Public Meetings Act, and the mailing of regular meeting schedules or revisions thereof to persons requesting same under Paragraph 14 of said act.

RULE TWENTY-SEVEN

Public comment shall be afforded all members of the general public at each regular and special meeting of the Mayor and Borough Council. Any member of the general public desiring to address the governing body shall do so upon recognition of said speaker by the Mayor or Presiding Officer. The speaker shall first identify themself by name and address. The speaker shall be permitted to address the governing body on any topic that is for the good and welfare of the general public. Public comments, questions, or other reasons for an appearance at the meeting shall be limited to five (5) minutes per speaker. Persons making public comments are not permitted to yield their allotted time to another individual. No questioning of individual members of Council shall be permitted by any speaker. In the event a speaker wished to pose a question to any individual member, they shall address the question to the Mayor or Presiding Officer, the time limitation imposed by this Rule may be waived or modified by the Mayor or Presiding Officer or by a majority of the Council Members present, upon motion duly made and seconded. No member of the public shall be allowed to poll the council on any issue. The Mayor or the Presiding Officer shall on all occasions preserve the strictest order and decorum and shall cause the removal of all persons who interrupt the orderly proceedings of the Governing Body.

Due to the current circumstances relating to the COVID-19 pandemic, the Mayor and Council have determined to also accept public comments in writing via electronic mail sent to publicmtgcomment@metuchen.com or mailed or delivered to the Borough Clerk. Said public comments shall be read aloud at the Mayor and Council meetings. Written public comments shall be read aloud by the Mayor or the Presiding Officer or their designee after all members of the public in attendance who wish to provide public comment are accommodated. Written public comments shall be limited to five (5) minutes per person. Public comments shall be read from the beginning, until the time limit is reached. Multiple public comments submitted by the same individual or entity shall be read in succession until the time limit is reached. The Mayor or the Presiding Officer may pass over duplicate written comments; however, each duplicate comment shall be noted for the record with the content summarized. WHEREAS, on August 20, 2021, Acting Attorney General Andrew J. Bruck announced that New Jersey intends to join nationwide settlement agreements with New Jersey based pharmaceutical company Johnson & Johnson and the United States' three largest pharmaceutical distributors, McKesson, Cardinal Health and AmerisourceBergen, to resolve claims involving their roles in fomenting the country's opioid crisis; and

WHEREAS, participation in the nationwide settlements will not only hold the companies financially accountable by requiring payments of as much as \$26 billion, the settlements will provide funding to support programs that address the opioid epidemic in New Jersey and across the country, and will require significant changes in the pharmaceutical industry aimed at preventing similar crises in the future; and

WHEREAS, the proposed settlements provide:

"the Distributors to pay up to \$21 billion over 18 years and Janssen to pay up to \$5 billion over no more than 9 years, for a total of \$26 billion (the "Settlement Amount"). Of the Settlement Amount, approximately \$22.7 billion is earmarked for use by participating states and subdivisions to remediate and abate the impacts of the opioid crisis. The Settlements also contain injunctive relief provisions governing the opioid marketing, sale and distribution practices at the heart of the states' and subdivisions' lawsuits and further

require the Distributors to implement additional safeguards to prevent diversion of prescription opioids;" and

WHEREAS, participation by a significant number of states, county, and municipal governments nationwide must agree to the proposed terms in order for the settlements to take effect; and

WHEREAS, provided enough states opt to participate in the settlements, their subdivisions will have through January 2, 2022 to join; and
