The Regular Meeting of the Borough Council was held in the Council Chambers of Borough Hall on Monday, March 28, 2022.

The Meeting was called to order at 7:31 p.m. by Mayor Busch.

Adequate Notice of this meeting has been given in accordance with the Open Public Meeting Act, pursuant to Public Law 1975, Chapter 231. Said notice was sent to the Home News Tribune and Star Ledger on January 7, 2022, posted in Borough Hall, and on file in the Clerk's Office. All requirements of the Open Public Meetings Act have been satisfied.

Mayor Busch asked for a moment of silence in memory of lifetime Metuchen resident Marty Jessen.

Mayor Busch asked all to rise for the flag salute.

Roll Call

Mayor Busch asked for a roll call.

Present were Councilmembers Branch, Hirsch, Kandel, Koskoski, Rasmussen, Council President Delia, and Mayor Busch. Also present were Denis Murphy, Borough Attorney, Melissa Perilstein, Borough Administrator, and Deborah Zupan, Acting Borough Clerk.

Agenda Session

Council President Delia made a motion to open the Agenda Session, second by Councilmember Rasmussen, with all in favor, motion carried, 6-0.

Council President Delia added Resolution 2022-105, regarding relaxing one of the special conditions for the Brown Stone's liquor license renewal.

Mayor Busch pulled Resolution 2022-93, appointing a ne Chief of Police, from the New Business Consent Agenda to be voted on separately.

With no further actions taken, Council President Delia made a motion to close the Agenda Session, second by Councilmember Rasmussen, with all in favor, motion carried, 6-0.

Hsihsi Chung, Library Director, thanked the Mayor, Council, and Administrator for the financial support this project will provide for some Library improvements.

ORDINANCE 2022-04

Borough of Metuchen County of Middlesex State of New Jersey

ORDINANCE OF THE BOROUGH OF METUCHEN ADOPTING AN AMENDED REDEVELOPMENT PLAN FOR THE GULTON TRACT WITHIN THE BOROUGH OF METUCHEN, COUNTY OF MIDDLESEX, STATE OF NEW JERSEY

WHEREAS, pursuant to the Local Redevelopment and Housing Law, <u>N.J.S.A.</u> 40A:12A-1 et seq. (the "LRHL"), via Resolution No. 2015-226 adopted on September 8, 2015, the Borough Council of the Borough of Metuchen (the "Borough Council") designated Block 37, Lots 5.03, 5.05, 5.12, 5.22, 6, 7.01, 7.02, 13, 14, 15.01, 16.02, 16.03, 17.01 & 17.02; Block 42, Lots 1-7; and, Block 66, Lots 1-3 as a "Non-Condemnation Redevelopment Area" (the "Gulton Tract"); and

WHEREAS, the Borough Council, pursuant to Resolution #2020-50, designated the entire Borough of Metuchen, County of Middlesex, including the Gulton Tract an "Area in Need of Rehabilitation" pursuant to N.J.S.A. 40A:12A-1 et seq. (the "Rehabilitation Area"); and

WHEREAS, in order to facilitate the redevelopment of the Rehabilitation Area, the Council adopted Ordinance 2020-10 on May 26, 2020, adopting a redevelopment plan entitled "Redevelopment Plan for Rehabilitation in the Borough of Metuchen, dated March 2020, ("Original Redevelopment Plan") after review by the Borough Planning Board (the "Planning Board"), pursuant to N.J.S.A. 40A:12A-7; and

WHEREAS, by way of Ordinance No. 2021-19, adopted on September 27, 2021, the Borough Council adopted the "Gulton Tract Redevelopment Plan" prepared by LRK, Inc., dated September 10, 2021, which superseded the 2020 Redevelopment Plan in its entirety, as it relates to the Gulton Tract only ("Gulton Tract Redevelopment Plan"), and which set forth, inter alia, the plans for the planning, development, redevelopment, and rehabilitation of the Gulton Tract; and

WHEREAS, the Borough has determined it is necessary to create more specific design standards for the redevelopment and rehabilitation of the Gulton Tract to ensure high-quality site

development and building design that is appropriate and necessary given its highly visible gateway location as well as adjacent open spaces and residential areas; and

- **WHEREAS**, the Borough has determined that adoption of an amended redevelopment plan for the Gulton Tract is necessary to incorporate these more specific design standards and has prepared an amended redevelopment plan entitled, "Amended Gulton Tract Redevelopment Plan," prepared by LRK, Inc. (the "Amended Gulton Tract Redevelopment Plan"); and
- **WHEREAS**, pursuant to <u>N.J.S.A.</u> 40A:12A-7, a governing body may adopt, revise or amend a redevelopment plan; and
- **WHEREAS,** in order to facilitate the rehabilitation and redevelopment of the Gulton Tract, the Planning Board, pursuant to N.J.S.A. 40A:12A-7, reviewed the Amended Gulton Tract Redevelopment Plan which will support and promote the adaptive reuse, rehabilitation and redevelopment of the Gulton Tract; and
- **WHEREAS**, pursuant to N.J.S.A. 40A:12A-7, the Planning Board recommended to the Borough Council that the Amended Gulton Tract Redevelopment Plan, which is on file with the Borough Clerk's office, be adopted, as it provides for improved planning, development, redevelopment, and rehabilitation of the Gulton Tract and is consistent with the Borough Master Plan; and
- **WHEREAS**, the Amended Gulton Tract Redevelopment Plan shall supersede the development regulations of the Borough's Zoning Ordinance, to the extent set forth therein, and the Borough Zoning Map is hereby amended to conform with the provisions of the Amended Gulton Tract Redevelopment Plan; and
- **WHEREAS,** the Borough Council has determined that it is in the best interest of the Borough to adopt the Amended Gulton Tract Redevelopment Plan, as recommended by the Board, to effectuate the rehabilitation and redevelopment of the Borough.
- **NOW THEREFORE BE IT ORDAINED,** by the Borough Council of the Borough of Metuchen, Middlesex County, State of New Jersey, as follows:
- <u>Section 1.</u> The Borough hereby adopts the "Amended Gulton Tract Redevelopment Plan" to facilitate the rehabilitation and redevelopment of the Borough of Metuchen.
- <u>Section 2.</u> The Borough Council declares and determines that said Amended Gulton Tract Redevelopment Plan meets the criteria, guidelines, and conditions set forth in <u>N.J.S.A.</u> 40A:12A-7, provides realistic opportunities for the rehabilitation and redevelopment of the Borough, and is otherwise in conformance with <u>N.J.S.A.</u> 40A:12A-1, <u>et seq.</u>
- <u>Section 3.</u> The Borough Council shall have, be entitled to, and is hereby vested all power and authority granted by the aforementioned statutory provisions to effectuate the Amended Gulton Tract Redevelopment Plan.
- <u>Section 4.</u> The Amended Gulton Tract Redevelopment Plan shall supersede the development regulations of the Borough's Zoning Ordinance, to the extent set forth therein, and the Borough Zoning Map is hereby amended to conform with the provisions of the Amended Gulton Tract Redevelopment Plan.
- <u>Section 5.</u> All ordinances or parts of ordinances inconsistent with this Ordinance are hereby repealed to the extent of such inconsistency.
- <u>Section 6.</u> In the event any clause, section or paragraph of this Ordinance is deemed invalid or unenforceable for any reason, it is the intent of the Borough Council that the balance of the Ordinance remains in full force and effect to the extent it allows the Borough to meet the goals of the Ordinance.
- <u>Section 7.</u> This Ordinance shall take effect after final adoption and publication according to law.

- **WHEREAS,** the Borough received five (5) proposals to provide Janitorial Services to Metuchen; and
- WHEREAS, Metuchen through a Committee comprised of the Borough Administrator, the Public Works Director and the QPA evaluated the proposals submitted based upon the criteria set forth in the RFP and have determined and recommended the award of contract to AAA Facilities Solutions LLC for the provision of Janitorial Services in the total amount not to exceed Thirty-four Thousand Eight Hundred Forty Dollars (\$34,840.00) for Janitorial Services for a contract term of one year to be effective upon passage of this resolution of contract award, and
- **WHEREAS**, the Mayor and Council of the Borough of Metuchen have determined that it to be in the best interest of Metuchen to authorize the award of contract for Janitorial Services to AAA Facilities Solutions LLC; and
- **WHEREAS**, the maximum amount for Janitorial Services for the Borough of Metuchen for the 2022 portion of this contract award is \$ 34,840.00 and that the Chief Financial Officer certifies that there are sufficient funds for such award and is available and is designated from 2022 Temporary Budget and 2022 Adopted Budget Current Fund appropriation Buildings & Grounds-Contractual Services 2-01-26-772-109 in the amount of \$28,250.00, and Library-Building Maintenance 2-01-29-800-024 in the amount of \$6,590.00.

- **WHEREAS**, the CENTRAL JJIF has adopted the new 2022 SAFETY INCENTIVE PROGRAM which should succeed in providing a safe, healthful, and pleasant environment.
- **NOW THEREFORE BE IT RESOLVED**, by the Borough Council of the Borough of Metuchen, County of Middlesex, State of New Jersey that the Central Jersey Joint Insurance Fund SAFETY INCENTIVE PROGRAM be adopted by the Borough of Metuchen.

RESOLUTION SUPPORTING THE 2022 'UDRIVE. UTEXT. UPAY' DISTRACTED DRIVING CRACKDOWN APRIL 1-30, 2022

- **WHEREAS**, distracted driving is a serious, life-threatening practice that is preventable; and
- **WHEREAS**, distracted driving can result in injuries and deaths to all road users (motorists, pedestrians, and bicyclists); and
- **WHEREAS**, distracted driving occurs when drivers divert their attention away from the task of driving to focus on another activity instead; and
- **WHEREAS**, in 2019 alone distracted driving-related crashes resulted in 3,142 deaths and 400,000 injuries on our nation's roads; and
- **WHEREAS**, in New Jersey distracted driving was listed as a contributing circumstance in 49-percent of all motor vehicle crashes in 2019; and
- **WHEREAS**, the State of New Jersey will participate in the nationwide Distracted Driving 2022 Crackdown from April 1 30, 2022 in an effort to raise awareness and decrease driver distraction through a combination of enforcement and education; and
 - WHEREAS, the national slogan for the campaign is UDrive. UText. UPay; and
- **WHEREAS**, a reduction in distracted driving in New Jersey will save lives on our roadways.
- **NOW THEREFORE BE IT RESOLVED,** that the Mayor and Council of the Borough of Metuchen declare their support for the Distracted Driving 2022 Crackdown both locally and nationally from April 1 30, 2022 and pledge to increase awareness of the dangers of distracted driving.
