ORDINANCE TO AMEND § 110-201 (ESTABLISHMENT; MEMBERSHIP) IN ARTICLE 51 (ZONING BOARD OF ADJUSTMENT), IN PART V (ORGANIZATION, POWERS AND PROCEDURE) IN CHAPTER 110 (LAND DEVELOPMENT) OF THE CODE OF THE BOROUGH OF METUCHEN TO INCREASE THE NUMBER OF ALTERNATE MEMBERS OF THE BOARD TO FOUR ALTERNATE MEMBERS

**BE IT ORDAINED** BY THE MAYOR AND COUNCIL OF THE BOROUGH OF METCUHEN:

**SECTION 1.** § 110-201 (Establishment; Membership) in Article 51 (Zoning Board of Adjustment), in Part V (Organization, Powers and Procedure) in Chapter 110 (Land Development) of the Code of the Borough of Metuchen is hereby amended to read as follows:

#### § 110-201. Establishment; membership

There is hereby established, pursuant to N.J.S.A. 40:55-69, a Zoning Board of Adjustment consisting of seven regular members and two-four alternate members as hereinafter provided.

- A. Regular members: Seven residents of the Borough who shall be nominated by the Mayor subject to confirmation, following advice and consent, by the Borough Council in the manner provided for other appointments under the Borough Act, as set forth at N.J.S.A. 40A:60-5(g) and N.J.S.A. 40A:60-6(d). Regular members shall serve for a term of four years
- B. Alternate members: Not more than two four alternate members to be appointed by the Mayor. Such alternate members shall be designated by the Mayor as "Alternate No. 1," and "Alternate No. 2," Alternate No. 3," and Alternate No. 4." Alternate members may participate in discussions of the proceedings, but may not vote except in the absence or disqualification of a regular member. In the event that a choice must be made as to which alternate member is to vote, Alternate No. 1 shall vote, then Alternate No. 2, etc. A vote shall not be delayed in order that a regular member may vote instead of an alternate member. Alternate members shall meet the qualifications pertaining to regular members of the Zoning Board of Adjustment. Alternate members shall serve for a term of two years, except that the terms of no more than two alternate members shall expire in any one year.

**SECTION 2**. All ordinances or parts of ordinances inconsistent herewith are hereby repealed to the extent of such inconsistency.

**SECTION 3.** If any portion of this ordinance shall be determined to be invalid, such determination shall not affect the validity of the remaining portions of said ordinance.

**SECTION 4.** This ordinance shall take effect upon final passage and publication in accordance with law and upon filing with the Middlesex County Planning Board.

#### BOND ORDINANCE AMENDING A BOND ORDINANCE FINALLY ADOPTED APRIL 10, 2023 BY THE BOROUGH COUNCIL OF THE BOROUGH OF METUCHEN, IN THE COUNTY OF MIDDLESEX, STATE OF NEW JERSEY, IN ORDER TO PROVIDE FOR CHANGES THEREIN

**BE IT ORDAINED** BY THE BOROUGH COUNCIL OF THE BOROUGH OF METUCHEN, IN THE COUNTY OF MIDDLESEX, STATE OF NEW JERSEY (the "Borough) (not less than two-thirds of all the members thereof affirmatively concurring), AS FOLLOWS:

- Section 1. The bond ordinance of the Borough, finally adopted April 10, 2023 and entitled, "Bond Ordinance Appropriating \$2,913,615 and Authorizing \$2,355,000 Bonds or Notes of the Borough for Various Improvements and Purposes Authorized to be Undertaken by the Borough of Metuchen, in the County of Middlesex, New Jersey" (the "Original Ordinance"), is hereby amended as follows:
- (i) all references in the Original Ordinance to the appropriation or cost of "\$2,913,655" are hereby deleted and "\$3,383,892" is substituted in lieu thereof.
- (ii) all references in the Original Ordinance to the down payment of "\$125,000" are hereby deleted and "\$595,277" is substituted in lieu thereof.
  - Section 2. All other details of the Original Ordinance shall remain the same.
- Section 3. This bond ordinance shall take effect twenty (20) days after the first publication thereof after final adoption, as provided by the Local Bond Law, constituting Chapter 2 of Title 40A of the New Jersey Revised Statutes.

**WHEREAS**, Chapter 185 of the Code of the Borough of Metuchen regulates vehicles, traffic and parking within the Borough of Metuchen; and

WHEREAS, § 185-23 of the Code of the Borough of Metuchen specifically designates the locations of "Multiway stop intersections" within the Borough; and

WHEREAS, the Chief of Police and the Borough Engineer have investigated, determined and recommend to the Mayor and Borough Council that it is in the best interest of the safety and welfare of its residents, and the community, in general, to establish a three-way, "Multiway stop intersection" at the Center Street and Durham Avenue intersection; and

WHEREAS, the Council of the Borough of Metuchen has determined to accept the recommendation of the Chief of Police and Borough Engineer finding that that it is in the best interest of the safety and welfare of its residents and the community, in general, to establish a three-way "Multiway Stop Intersection" at Center Street and Durham Avenue and to amend the Borough Code accordingly.

**NOW THEREFRORE BE IT ORDAINED** by the Council of the Borough of Metuchen, County of Middlesex that it hereby amends § 185-23 of the Code of the Borough of Metuchen to include the following location:

#### § 185-23 Multiway stop intersections.

Pursuant to the provisions of N.J.S.A. 39:4-140, the intersections herein described are designated as multiway stop intersections. Stop signs shall be installed as provided therein.

Intersection	Stop Sign(s) On
Center Street and Durham Avenue	All approaches (Three-way) - Northbound and Southbound on Center Street and Westbound on Durham Avenue at the intersection of Center Street and Durham Avenue

**BE IT FURTHER ORDAINED** by the Mayor and Council that all remaining locations contained in the Table in §185-23 shall remain "Multiway Stop Intersections" and shall not be affected by the within amendments and shall remain in full force and effect.

**BE IT FURTHER ORDAINED** that should any section, paragraph, sentence, clause, or phase of this ordinance be declared unconstitutional or invalid for any reason, the remaining portion of this ordinance shall not be affected thereby and shall remain in full force and effect, and to that end the provisions of this ordinance are hereby declared to be severable; and

**BE IT FURTHER ORDAINED** that all ordinances or parts of ordinances inconsistent with this amending ordinance are hereby repealed to the extent of their inconsistencies only; and

**BE IT FURTHER ORDAINED** that this ordinance shall be in full force and take effect after final passage and publication, as required by law.

**BE IT FURTHER ORDAINED** by the Mayor and Borough Council of the Borough of Metuchen that all Borough officials and employees shall take all necessary actions to in order to effectuate and enforce the within Ordinance, including but not limited to the installation of a stop sign/s in the above designated area.

## ORDINANCE AMENDING THE CODE OF THE BOROUGH OF METUCHEN AND THE COMPOSITION OF THE SENIOR CITIZENS COMMISSION DECREASING ITS MEMBERSHIP FROM ELEVEN (11) MEMBERS TO NINE (9) MEMBERS

WHEREAS, the Mayor and Council of the Borough of Metuchen have determined that it is in the best interest of the Borough to amend the composition of the Senior Citizens Commission of the Borough of Metuchen decreasing its membership from eleven (11) members to nine (9) members.

**NOW THEREFORE BE IT ORDAINED,** by the Council of the Borough of Metuchen that it hereby amends Chapter 10, Article 4 of the Code of the Borough of Metuchen, specifically § 10-20, entitled "Establishment; composition; term of office; vacancies" to state as follows:

#### **Article 4. Senior Citizens Commission**

#### § 10-20. Establishment; composition; term of office; vacancies.

- A. There is hereby established a Senior Citizens Commission for the Borough of Metuchen which shall consist of 11 9 members who shall be appointed by the Mayor with the advice and consent of the Borough Council. No person shall be appointed to the Senior Citizens Commission unless he or she is a resident of the Borough of Metuchen.
- B. Each member shall be appointed for a term of three years; however, at the time of the creation of the Commission, three shall be appointed for three years, three shall be appointed for two years and three shall be appointed for one year. Thereafter, each appointment shall be for three years. Members shall serve after the expiration of their terms until the respective successors shall have been appointed and have qualified.
- C. Vacancies occurring other than by the expiration of the term shall be filled in like manner but for the balance of the unexpired term only.
- D. The Commission shall designate one of its members as Chairperson, and he or she shall serve as such until the first day of January next following the appointment and until his or her successor shall be appointed and qualify. All members shall serve without compensation.
- **BE IT FURTHER ORDAINED,** by the Mayor and Council that all prior ordinances, or sections of ordinances, inconsistent with the within ordinance are hereby repealed.
- **BE IT FURTHER ORDAINED,** by the Mayor and Council that all remaining sections of Chapter 10, not amended herein, including but not limited to Section 21 shall not be affected hereby and shall remain in full force and effect.
- **BE IT FURTHER ORDAINED,** by the Mayor and Council that if any section, subsection, paragraph, sentence, clause or phrase of this Ordinance shall be declared invalid for

any reason whatsoever, such decision shall not affect the remaining portions of this Ordinance, which shall continue in full force and effect, and to this end, the provisions of this Ordinance are hereby declared to be severable.

**BE IT FURTHER ORDAINED,** by the Mayor and Council that this ordinance shall become effective immediately upon final passage and publication as provided by law.

WHEREAS, upon the recommendation of the Borough Administration, the Borough of Metuchen has determined that it is in the best interest of the Borough and the efficiency of processing applications for the use of the Borough Fields to change the Borough official to obtain the applications for permits from and to whom the applications are to be submitted to from the Borough Clerk to the Recreation Director.

**NOW THEREFORE, BE IT ORDAINED** that the Council of the Borough of Metuchen, County of Middlesex, State of New Jersey, hereby amends § 124-28(B)(1) of the Code of the Borough of Metuchen to state as follows:

#### § 124-28 (B)(1)

- A. Miscellaneous requirements.
  - 1. Applications can be obtained from and returned to the Recreation Director. the Borough Clerk and also returned to the Borough Clerk. The Borough Clerk will review for completeness (checklist provided). If application is incomplete it will be returned to the applicant and missing information identified. Upon submission of a complete application, the application shall be forwarded to the Recreation Director for consideration.

**BE IT FURTHER ORDAINED,** by the Mayor and Council that all remaining sections of Chapter 124, and § 124-28, not specifically amended herein, including but not limited to § 124-28(A), § 124-28(B)(2) through § 124-28(B)(5), and § 124-28(C) through § 124-28(H) shall not be affected hereby and shall remain in full force and effect.

**BE IT FURTHER ORDAINED,** by the Mayor and Council that all prior ordinances, or sections of ordinances, inconsistent with the within ordinance are hereby repealed.

**BE** IT FURTHER ORDAINED, by the Mayor and Council that if any section, subsection, paragraph, sentence, clause or phrase of this Ordinance shall be declared invalid for any reason whatsoever, such decision shall not affect the remaining portions of this Ordinance,

which shall continue in full force and effect, and to this end, the provisions of this Ordinance are hereby declared to be severable.

#### RESOLUTION AUTHORIZING BID AWARD FOR 2023 ROAD PROGRAM

WHEREAS, fourteen (14) bids were received by the Borough Clerk, Borough Engineer, Qualified Purchasing Agent, and Borough Administrator on or before November 22, 2023, for the 2023 Road Program for the Borough of Metuchen: and

**WHEREAS**, the Borough Council has reviewed the letter of recommendation made by the Borough Engineer on said bid, dated November 22, 2023; and

WHEREAS, the maximum amount of award for the 2023 Road Program is \$1,953,033.29 for various roads to include Wakefield Drive, Lexington Drive, Concord Avenue, Prospect Street, Mayfield Place, High Street, Waltham Avenue, Beechwood Avenue, Homestead Road, and Penn Avenue parking lot. Funds are available in the 2023 Capital Bond Ordinance 2023-07 as certified by the Chief Finance Officer. Sufficient funds are designated from Capital Bond Ordinance 2023-07, Account C-04-55-939-012 in the amount of \$433,615.00, C-04-55-939-013 in the amount of \$1,364,418.29 and C-04-939-014 in the amount of \$155,000.00.
