ORDINANCE TO AMEND § 110-201 (ESTABLISHMENT; MEMBERSHIP) IN ARTICLE 51 (ZONING BOARD OF ADJUSTMENT), IN PART V (ORGANIZATION, POWERS AND PROCEDURE) IN CHAPTER 110 (LAND DEVELOPMENT) OF THE CODE OF THE BOROUGH OF METUCHEN TO INCREASE THE NUMBER OF ALTERNATE MEMBERS OF THE BOARD TO FOUR ALTERNATE MEMBERS

**BE IT ORDAINED** BY THE MAYOR AND COUNCIL OF THE BOROUGH OF METCUHEN:

**SECTION 1.** § 110-201 (Establishment; Membership) in Article 51 (Zoning Board of Adjustment), in Part V (Organization, Powers and Procedure) in Chapter 110 (Land Development) of the Code of the Borough of Metuchen is hereby amended to read as follows:

### § 110-201. Establishment; membership

There is hereby established, pursuant to N.J.S.A. 40:55-69, a Zoning Board of Adjustment consisting of seven regular members and four alternate members as hereinafter provided.

- A. Regular members: Seven residents of the Borough who shall be nominated by the Mayor subject to confirmation, following advice and consent, by the Borough Council in the manner provided for other appointments under the Borough Act, as set forth at N.J.S.A. 40A:60-5(g) and N.J.S.A. 40A:60-6(d). Regular members shall serve for a term of four years
- B. Alternate members: Not more than four alternate members to be appointed by the Mayor. Such alternate members shall be designated by the Mayor as "Alternate No. 1," "Alternate No. 2," Alternate No. 3," and Alternate No. 4." Alternate members may participate in discussions of the proceedings, but may not vote except in the absence or disqualification of a regular member. In the event that a choice must be made as to which alternate member is to vote, Alternate No. 1 shall vote, then Alternate No. 2, etc. A vote shall not be delayed in order that a regular member may vote instead of an alternate member. Alternate members shall meet the qualifications pertaining to regular members of the Zoning Board of Adjustment. Alternate members shall serve for a term of two years, except that the terms of no more than two alternate members shall expire in any one year.

**SECTION 2**. All ordinances or parts of ordinances inconsistent herewith are hereby repealed to the extent of such inconsistency.

**SECTION 3.** If any portion of this ordinance shall be determined to be invalid, such determination shall not affect the validity of the remaining portions of said ordinance.

**SECTION 4.** This ordinance shall take effect upon final passage and publication in accordance with law and upon filing with the Middlesex County Planning Board.

Section 1. ### **Reports Of Council Members**

Council President Delia reported that the Traffic and Transportation Committee met this month and welcomed a new member, and that the Parking Authority met yesterday. He also reported that he had visited the Senior Center to talk about parking changes, and how to use the meters and app.

Councilmember Kandel reported that the Historic Preservation Committee continues to be concerned about the demolition of potentially historic structures and had been discussing potential options to address this matter. He noted that the Pool Commission had recently discussed equipment that is in need of replacement or repair, and that they have been working to make sure Summer 2024 is a great season. The Pool Commission also discussed improving entertainment options at the pool and ways to increase revenue.

Councilmember Jethwani reported on upcoming Library events including an art show at the Library Gallery, a jazz documentary film, and their annual Lunar New Year celebration. Councilmember Jethwani noted that, at the January Library Board meeting, Library Director Hsihsi Chung announced her retirement.

Councilmember Hyman reposted that the first Board of Health had been rescheduled for the following week, and the first Parade Commission meeting was delayed as well due to weather. She reported that the CARES Committee has plans for an exciting year ahead, including an educational campaign through social media, a program for senior citizens on maintaining a healthy mind, purchasing materials for a teen issues collection at the Library. The Committee also met with parents regarding planning for Project Graduation.

Councilmember Branch reported that, along with Councilmember Hyman, he attended a special service at New Hope Baptist Church over Martin Luther King weekend. He thanked Reverend Ownes for planning this interdenominational event every year. Councilmember Branch noted that the Human Relations Commission, Recreation Commission, and Arts Council have all had their initial meetings to discuss programming for the upcoming year.
