BOROUGH OF METUCHEN COUNCIL MINUTES January 29, 2024 7:30 PM

The Regular Meeting of the Borough Council was held in the Council Chambers of Borough Hall on January 29, 2024.

The Meeting was called to order at 7:30 p.m. by Mayor Busch.

Adequate Notice of this meeting has been given in accordance with the Open Public Meeting Act, pursuant to Public Law 1975, Chapter 231. Said notice was published in the Home News Tribune on December 19, 2023, posted in Borough Hall, and on file in the Clerk's Office. All requirements of the Open Public Meetings Act have been satisfied.

Mayor Busch asked for a moment of silence in honor of the passing of former Councilmember James Bernard Dudley.

Mayor Busch asked for all to rise for the flag salute.

Roll Call

Mayor Busch asked for a roll call.

Present were Councilmembers Branch, Hyman, Jethwani, Kandel, Delia, and Mayor Busch. Councilmember Giamboi was absent, as was Borough Administrator Melissa Perilstein. Also present were Deborah Zupan, Borough Clerk and Denis Murphy, Borough Attorney.

Agenda Session

Council President Delia made a motion to open the Agenda Session, second by Councilmember Kandel, with all in favor, motion carried, 5-0.

With no action taken, Council President Delia made a motion to close the Agenda Session, second by Councilmember Kandel, with all in favor, motion carried, 5-0.

Public Comment

Mayor Busch opened Public Comment to any members of the public wishing to speak.

Lynne Mueller, 110 Christol Street, commented that the Metuchen train station building is often closed, leaving people to wait outside in bad weather on weekends, afternoons, and evenings. Mayor Busch responded that the Borough has a good relationship with NJ Transit and that he would look into this matter.

Patricia "Dolly" Kuenseler, 57 Prospect Street, asked if her street would be repaved soon, as it has been slated for repaving for some time. Mayor Busch responded that Prospect Street was indeed scheduled for repaving soon, but that there were many factors that could affect the timeline. Ms. Kuenseler also asked why so many other streets have had utility work done, but Prospect Street had not. She commented that parking in the parking garage was not convenient for shopping at the Farmers Market because it's too far a distance when people, particularly senior citizens, have several bags to carry. Finally, Ms. Kuenseler asked about the progress of work on Bridge Street. Mayor Busch assured Ms. Kuenseler that he would follow up with her on these matters.

Jenna Pusillo, 292 High Street, spoke on behalf of her neighbors regarding the Metuchen Sports Center. Ms. Pusillo noted that the Sports Center does not have adequate parking, causing many cars to be parked on their one-way, dead end street, blocking driveways and causing terrible traffic. She also noted that excessive noise from Sports Center events impacts the neighborhood, sometimes starting as early at 5: a.m. and going on until 2:00 a.m., and that there is often a lot of garbage left behind. Ms. Pusillo suggested having resident parking only, and only on one side of the street, to help alleviate the parking issue. Mayor Busch responded that he would speak with the Police Chief and that he would have the Chief reach contact her to discuss these issues.

Borough Council Meeting January 29, 2024

Rayan Charara, 296 High Street, commented that he had the same concerns as Ms. Pusillo and added that he was concerned for the future of his baby given the traffic situation. Mr. Charara mentioned the music and noise from 5:00 a.m. to 2:00 a.m. He also commented on the trucks often coming down their residential street and mentioned that their portion of High Street is in need of paving. Finally, Mr. Charara noted that the lights in the Momentum Solar parking lot located in their neighborhood were very bright. Mayor Busch responded that he would take the residents' concerns into consideration, specifically asking that they send an email summarizing these concerns, and that he would see what could be done.

Fred Kimler, 292 High Street, commented that he's seen many positive changes with the town being built up but with these changes, changes need to be made to consider safety as well. Mr. Kimler echoed his neighbors' concerns about safety given the increased traffic to their street and mentioned how careless many of the cares associated with the Sports Center are. He also mentioned that many cars idle on their street.

Peter Hoang, 288 High Street, reiterated that the traffic on his portion of High Street is terrible during the Sport Center's open hours. He added that drivers often park in the wrong direction, and that this is increasingly an issue in other parts of town as well. Mr. Hoang also brought up an issue with the storm drains on their street. Mayor Busch again assured residents he would look into these issues.

Jane Kimler Pusillo, 292 High Street, expressed her concern about the trucks to and from Momentum Solar and commented that, in addition to presenting extensive safety issues, they have damaged the street and sewers. Ms. Pusillo noted that she has tried, unsuccessfully, to address these concerns with Momentum. She also questioned why these businesses were not being held accountable for their actions by the Borough. Mayor Busch again assured residents he would look into these issues.

Seeing no one else wishing to speak, Mayor Busch closed the Public Comment.

ORDINANCE 2024-03

Borough of Metuchen County of Middlesex State of New Jersey

ORDINANCE AMENDING § 185-23 OF THE CODE OF THE BOROUGH OF METUCHEN ESTABLISHING A MULTIWAY STOP INTERSECTION (THREE WAY) AT CENTER STREET AND DURHAM AVENUE

WHEREAS, Chapter 185 of the Code of the Borough of Metuchen regulates vehicles, traffic and parking within the Borough of Metuchen; and

WHEREAS, § 185-23 of the Code of the Borough of Metuchen specifically designates the locations of "Multiway stop intersections" within the Borough; and

WHEREAS, the Chief of Police and the Borough Engineer have investigated, determined and recommend to the Mayor and Borough Council that it is in the best interest of the safety and welfare of its residents, and the community, in general, to establish a three-way, "Multiway stop intersection" at the Center Street and Durham Avenue intersection; and

WHEREAS, the Council of the Borough of Metuchen has determined to accept the recommendation of the Chief of Police and Borough Engineer finding that that it is in the best interest of the safety and welfare of its residents and the community, in general, to establish a three-way "Multiway Stop Intersection" at Center Street and Durham Avenue and to amend the Borough Code accordingly.

NOW THEREFRORE BE IT ORDAINED by the Council of the Borough of Metuchen, County of Middlesex that it hereby amends § 185-23 of the Code of the Borough of Metuchen to include the following location:

§ 185-23 Multiway stop intersections.

Pursuant to the provisions of N.J.S.A. 39:4-140, the intersections herein described are designated as multiway stop intersections. Stop signs shall be installed as provided therein.

BE IT FURTHER ORDAINED by the Mayor and Council that all remaining locations contained in the Table in §185-23 shall remain "Multiway Stop Intersections" and shall not be affected by the within amendments and shall remain in full force and effect.

BE IT FURTHER ORDAINED that should any section, paragraph, sentence, clause, or phase of this ordinance be declared unconstitutional or invalid for any reason, the remaining portion of this ordinance shall not be affected thereby and shall remain in full force and effect, and to that end the provisions of this ordinance are hereby declared to be severable; and

BE IT FURTHER ORDAINED that all ordinances or parts of ordinances inconsistent with this amending ordinance are hereby repealed to the extent of their inconsistencies only; and

BE IT FURTHER ORDAINED that this ordinance shall be in full force and take effect after final passage and publication, as required by law.

BE IT FURTHER ORDAINED by the Mayor and Borough Council of the Borough of Metuchen that all Borough officials and employees shall take all necessary actions to in order to effectuate and enforce the within Ordinance, including but not limited to the installation of a stop sign/s in the above designated area.

ORDINANCE 2024-04

Borough of Metuchen County of Middlesex State of New Jersey

ORDINANCE AMENDING THE CODE OF THE BOROUGH OF METUCHEN AND THE COMPOSITION OF THE SENIOR CITIZENS COMMISSION DECREASING ITS MEMBERSHIP FROM ELEVEN (11) MEMBERS TO NINE (9) MEMBERS

WHEREAS, the Mayor and Council of the Borough of Metuchen have determined that it is in the best interest of the Borough to amend the composition of the Senior Citizens Commission of the Borough of Metuchen decreasing its membership from eleven (11) members to nine (9) members.

NOW THEREFORE BE IT ORDAINED, by the Council of the Borough of Metuchen that it hereby amends Chapter 10, Article 4 of the Code of the Borough of Metuchen, specifically § 10-20, entitled "Establishment; composition; term of office; vacancies" to state as follows:

Article 4. Senior Citizens Commission

§ 10-20. Establishment; composition; term of office; vacancies.

- A. There is hereby established a Senior Citizens Commission for the Borough of Metuchen which shall consist of 9 members who shall be appointed by the Mayor with the advice and consent of the Borough Council. No person shall be appointed to the Senior Citizens Commission unless he or she is a resident of the Borough of Metuchen.
- B. Each member shall be appointed for a term of three years; however, at the time of the creation of the Commission, three shall be appointed for three years, three shall be appointed for two years and three shall be appointed for one year. Thereafter, each appointment shall be for three years. Members shall serve after the expiration of their terms until the respective successors shall have been appointed and have qualified.
- C. Vacancies occurring other than by the expiration of the term shall be filled in like manner but for the balance of the unexpired term only.
- D. The Commission shall designate one of its members as Chairperson, and he or she shall serve as such until the first day of January next following the appointment and until his or her successor shall be appointed and qualify. All members shall serve without compensation.
- **BE IT FURTHER ORDAINED,** by the Mayor and Council that all prior ordinances, or sections of ordinances, inconsistent with the within ordinance are hereby repealed.
- **BE IT FURTHER ORDAINED,** by the Mayor and Council that all remaining sections of Chapter 10, not amended herein, including but not limited to Section 21 shall not be affected hereby and shall remain in full force and effect.
- **BE IT FURTHER ORDAINED,** by the Mayor and Council that if any section, subsection, paragraph, sentence, clause or phrase of this Ordinance shall be declared invalid for any reason whatsoever, such decision shall not affect the remaining portions of this Ordinance, which shall continue in full force and effect, and to this end, the provisions of this Ordinance are hereby declared to be severable.
- **BE IT FURTHER ORDAINED,** by the Mayor and Council that this ordinance shall become effective immediately upon final passage and publication as provided by law.

ORDINANCE AMENDING § 124-28(B)(1) OF THE CODE OF THE BOROUGH OF METUCHEN CHANGING THE DESIGNATED OFFICAL TO OBTAIN AND SUBMIT APPLICATIONS FOR PERMITS FOR THE USE OF BOROUGH FIELDS FROM THE BOROUGH CLERK TO THE RECREATION DIRECTOR

WHEREAS, by way of Ordinance No. 2023-28, the Mayor and Council of the Borough of Metuchen created procedures for the application and permitting process for the use of Borough of Metuchen Fields; and

WHEREAS, upon the recommendation of the Borough Administration, the Borough of Metuchen has determined that it is in the best interest of the Borough and the efficiency of processing applications for the use of the Borough Fields to change the Borough official to obtain the applications for permits from and to whom the applications are to be submitted to from the Borough Clerk to the Recreation Director.

NOW THEREFORE, BE IT ORDAINED that the Council of the Borough of Metuchen, County of Middlesex, State of New Jersey, hereby amends § 124-28(B)(1) of the Code of the Borough of Metuchen to state as follows:

§ 124-28 (B)(1)

A. Miscellaneous requirements.Applications can be obtained from and returned to the Recreation Director.

BE IT FURTHER ORDAINED, by the Mayor and Council that all remaining sections of Chapter 124, and § 124-28, not specifically amended herein, including but not limited to § 124-28(A), § 124-28(B)(2) through § 124-28(B)(5), and § 124-28(C) through § 124-28(H) shall not be affected hereby and shall remain in full force and effect.

BE IT FURTHER ORDAINED, by the Mayor and Council that all prior ordinances, or sections of ordinances, inconsistent with the within ordinance are hereby repealed.

BE IT FURTHER ORDAINED, by the Mayor and Council that if any section, subsection, paragraph, sentence, clause or phrase of this Ordinance shall be declared invalid for any reason whatsoever, such decision shall not affect the remaining portions of this Ordinance, which shall continue in full force and effect, and to this end, the provisions of this Ordinance are hereby declared to be severable.

BE IT FURTHER ORDAINED, by the Mayor and Council that this ordinance shall become effective immediately upon final passage and publication as provided by law.
