ORDINANCE AMENDING § 124-28(B)(1) OF THE CODE OF THE BOROUGH OF METUCHEN CHANGING THE DESIGNATED OFFICIAL TO OBTAIN AND SUBMIT APPLICATIONS FOR PERMITS FOR THE USE OF BOROUGH FIELDS FROM THE BOROUGH CLERK TO THE RECREATION DIRECTOR

WHEREAS, by way of Ordinance No. 2023-28, the Mayor and Council of the Borough of Metuchen created procedures for the application and permitting process for the use of Borough of Metuchen Fields; and

WHEREAS, upon the recommendation of the Borough Administration, the Borough of Metuchen has determined that it is in the best interest of the Borough and the efficiency of processing applications for the use of the Borough Fields to change the Borough official to obtain the applications for permits from and to whom the applications are to be submitted to from the Borough Clerk to the Recreation Director.

NOW THEREFORE, BE IT ORDAINED that the Council of the Borough of Metuchen, County of Middlesex, State of New Jersey, hereby amends § 124-28(B)(1) of the Code of the Borough of Metuchen to state as follows:

§ 124-28 (B)(1)

A. Miscellaneous requirements.

Applications can be obtained from and returned to the Recreation Director.

BE IT FURTHER ORDAINED, by the Mayor and Council that all remaining sections of Chapter 124, and § 124-28, not specifically amended herein, including but not limited to § 124-28(A), § 124-28(B)(2) through § 124-28(B)(5), and § 124-28(C) through § 124-28(H) shall not be affected hereby and shall remain in full force and effect.

BE IT FURTHER ORDAINED, by the Mayor and Council that all prior ordinances, or sections of ordinances, inconsistent with the within ordinance are hereby repealed.


BE IT FURTHER ORDAINED, by the Mayor and Council that if any section, subsection, paragraph, sentence, clause or phrase of this Ordinance shall be declared invalid for any reason whatsoever, such decision shall not affect the remaining portions of this Ordinance, which shall continue in full force and effect, and to this end, the provisions of this Ordinance are hereby declared to be severable.

BE IT FURTHER ORDAINED, by the Mayor and Council that this ordinance shall become effective immediately upon final passage and publication as provided by law.




