**RESOLUTION AUTHORIZING BID AWARD FOR DEMOLITION/DEBRIS
REMOVAL/RESTORATION FOR 1 SAFETY PLACE**

WHEREAS, pursuant to the Local Public Contracts Law, N.J.S.A. 40A:11-1 et seq., the Borough of Metuchen advertised to receive bids on or before August 20, 2024 for Rebid Demolition/Debris Removal/Restoration for 1 Safety Place; and

WHEREAS, eight (8) bids were received by the Borough Clerk for the Demolition/Debris Removal/Restoration for 1 Safety Place for the Borough of Metuchen; and

WHEREAS, the bids were reviewed by the QPA for the Borough of Metuchen and has found that the lowest bid appears to be reasonable and is in compliance with the Bid Specification and recommends the award of the contract to Tekcon Construction, Inc. for the Demolition/Debris Removal/Restoration for 1 Safety Place contract; and

WHEREAS, the maximum amount for Demolition/Debris Removal/Restoration for 1 Safety Place for the Borough of Metuchen is thirty nine thousand five hundred dollars and no cents (\$39,500.00) and funds are available and that there are sufficient funds for such award as certified by the Chief Financial Officer from Capital Bond Ordinance 2023-14, C-04-55-943-001, not to exceed \$39,500.00.

NOW, THEREFORE, BE IT RESOLVED by the Borough Council of the Borough of Metuchen, County of Middlesex, State of New Jersey that the contract for the Demolition/Debris Removal/Restoration for 1 Safety Place be and the same is hereby awarded to lowest responsible bidder, Tekcon Construction, Inc., 285 Davidson Avenue, Suite 201, Somerset, NJ 08873.

BE IT FURTHER RESOLVED that the Mayor and the Borough Clerk are hereby authorized and directed to execute the contract for the same; and
