**RESOLUTION AUTHORIZING BID AWARD FOR 2024 ROAD PROGRAM**

**WHEREAS**, thirteen (13) bids were received by the Borough Clerk, Borough Engineer, Qualified Purchasing Agent, and Borough Administrator on or before September 26, 2024, for the 2024 Road Program for the Borough of Metuchen: and

**WHEREAS**, the Borough Council has reviewed the letter of recommendation made by the Borough Engineer on said bid, dated September 30, 2024; and

**WHEREAS**, the maximum amount of award for the 2024 Road Program is \$934,398.00 for various roads to include Grove Avenue, Rose Street and Newman Street. Funds are available in the 2024 Capital Bond Ordinance 2024-11 as certified by the Chief Finance Officer. Sufficient funds are designated from Capital Bond Ordinance 2024-11, Account C-04-55-944-014 in the amount of \$606,980.00 and C-04-55-944-015 in the amount of \$327,418.00 for a total award in the amount of nine hundred thirty four thousand three hundred ninety eight dollars and no cents (\$934,398.00).

**NOW, THEREFORE, BE IT RESOLVED** by the Borough Council of the Borough of Metuchen, County of Middlesex, State of New Jersey that the contract for the 2024 Road Program be and the same is hereby awarded to the lowest responsible bidder, P & A Construction, Inc., P.O. Box 28, Colonia, NJ 07067.

**BE IT FURTHER RESOLVED** that the Mayor and the Borough Clerk are hereby authorized and directed to execute the contract for the same; and
